- If submitted by 30 April, the team fee will be \$ 1,050.00. For every player above 15 (i.e., #16), the individual cost is \$ 70 per player.
- If fees are submitted after 30 April, but before 30 May, then team fee is \$1,200, with additional players beyond 15 at \$80 per player.
- If fees are submitted after 30 May, the team fee is \$1,350 per team, with additional players beyond 15 at \$ 90 per player.

Additional Banquet Tickets are available for non-players at a cost of \$20.00 per ticket. Persons purchasing Banquet Tickets must also complete and sign this form and complete the facility participant release.
